



**2CHAINZ FLYAWAY SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE CHANCES OF WINNING. VOID WHERE PROHIBITED.

SWEEPSTAKES DESCRIPTION:

The “2Chainz Flyaway” sweepstakes (“Sweepstakes”) will begin on June 15, 2017 and end on June 28, 2017 (“Sweepstakes Period”). This Sweepstakes will be conducted exclusively online. There will be one (1) national winner and three (3) guests of the winner’s choosing. The winner will be awarded: Four (4) roundtrip commercial economy class airline tickets; four (4) tickets to attend Pretty Girls Like Trap Music Tour Concert on winners’ date of selection; ground transportation to and from the destination airport and concert venue; dinner with the artist; backstage passes; and hotel accommodations (based on double occupancy) for two (2) nights (“Prize”). ELIGIBILITY:

The Sweepstakes is open to listeners of the Participating Radio One® Stations listed below who (a) are legal residents of the United States, (b) reside in the metropolitan area of one of the Participating Radio One® Stations, and (c) are twenty-one (21) years of age or older at the time of Sweepstakes registration.

Employees of the Participating Radio One® Stations, Urban One, Inc., Def Jam Recordings (also "Def Jam"), and each of their respective parents, subsidiaries, affiliates, participating advertising and promotion agencies, competitors, promotional partners, and prize suppliers, and members of their immediate families and/or those living in the same households (whether legally related or not) are NOT eligible to enter or win the Sweepstakes. For purposes of this Sweepstakes, immediate family members include spouse, children, siblings (and their spouses), parents, and grandparents.

Participants may only win one (1) prize during this Sweepstakes.

The winner and each adult travel guest must possess a valid state-issued driver's license or other government-issued identification document containing the person's name, date of birth, and photograph prior to departure. The winner and travel guests must travel together on the same itinerary from the originating city. Once selected by the winner, the travel guests cannot be changed without the express consent of Def Jam, which may be withheld for any reason.

Persons who have won a prize in another sweepstakes or promotion of any kind from any of the Participating Radio One® Stations within the thirty (30) day period immediately preceding the start date of the Sweepstakes are not eligible to enter or win. Only one person per family or household (whether related or not) may win in any promotion from the Participating Radio One® Stations during any thirty (30) day period.

Any person who is on the No Fly List maintained by the federal Terrorist Screening Center or who otherwise is prohibited from boarding a commercial aircraft for travel in or out of the United States will be ineligible to use the airfare portion of the Prize or to participate as a travel guest of the winner.

HOW TO ENTER:

- Sweepstakes participants must register online through the website of one of the Participating Radio One® Stations listed above in the Eligibility section.
- Upon entering the Sweepstakes website, participants must follow the instructions and complete all required fields to register for a chance to win.
- Entries are limited to one per person, per email address, per day during the Sweepstakes Period.
- All entries must be received by 11:59pm (ET) on June 28, 2017, or they will be deemed void.
- In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the email account at the time the entry was made.



WINNER SELECTION & NOTIFICATION:

One (1) winner will be selected by random drawing from among all eligible entries received during the Sweepstakes Period from the above listed Participating Radio One® Stations.

The drawing will be conducted by Radio One, whose decision is final. Odds of winning will depend upon the total number of eligible entries received.

The winner will be notified by phone and/or email at Sponsor’s discretion and provided with instructions for claiming the Prize. In the event that a winner does not respond to Sponsor’s notification or does not accept the prize within three (3) business days of notification, the prize will be deemed forfeited and an alternate winner will be selected from among the remaining eligible entries. Sponsor will use a reasonable number of attempts, in its discretion, to award the Prize to an alternate winner; but if it is unable to do so, the Prize will be finally forfeited and Sponsor will have no further liability in connection with the Sweepstakes.

In the event Sponsor does not receive any eligible entries, or receives an insufficient number of eligible entries, Sponsor has the right to cancel the Sweepstakes.

The Prize will be awarded only upon winner verification and final approval by Sponsor. The winner must provide valid government-issued photo identification to claim the Prize. Identification documents must match information previously provided to the Participating Radio One® Station.

PRIZE DESCRIPTIONS & CONDITIONS:

The following Prize elements will be awarded to one (1) winner from the Participating Radio One® Stations:

- Four (4) round trip, coach class, airline tickets to any one (1) of the U.S. Pretty Girls Like Trap Music Tour Stops (from a major airport located within the continental United States closest to the winner’s residence), to be selected in Promotion Partner’s sole discretion. Travel must originate from and end at the same airport. The winner and his/her guests must travel together on the same itinerary. Promotion Partner will not be responsible for any missed prizes, opportunities or expenses incurred as a consequence of flight cancelation or delay;
- Four (4) tickets to attend a Pretty Girls Like Trap Music Tour Concert on winner’s date of selection;
- Hotel accommodations for four (4) (two (2) standard double occupancy rooms) for two (2) nights, to be selected in Promotion Partner’s sole discretion;



- Local ground transportation to and from destination airport and the concert venue;
- Dinner for four (4); and
- Four (4) backstage passes
- The Approximate Retail Value (ARV) of the Prize is \$4,500. If the actual value of the Prize is less than the stated ARV, the difference will not be awarded in cash.
- Departure dates and accommodations are subject to availability; certain restrictions and blackout dates may apply.

An IRS Form 1099 will be issued in the name of the winner for the actual value of the Prize received. In the event any winner is found to be in violation of these Official Rules or is otherwise determined by Sponsor to be ineligible, the winner may be required to forfeit the Prize or to reimburse Sponsor for the stated ARV of the prize if such violation is discovered after the Prize has been used by the winner.

- Sponsor reserves the right to make changes to the Official Rules, which will become effective upon posting online, so long as no participant is materially adversely affected by any such changes.
- Sponsor is not responsible for the inability of any entrant to complete or transmit a Sweepstakes entry for any reason, whether due to technical malfunction or human error.
- Sponsor is not responsible for any errors or others acts resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by Sponsor on account of technical problems or traffic congestion on the Internet or on any website. Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes in the event of tampering, unauthorized intervention, fraud, technical failures, or any other causes that may corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes. Sponsor further reserves the right to select winners from eligible entries received as of the termination date and to disqualify any individual who tampers in any way with the entry process. Sponsor may prohibit an entrant from



participating in the Sweepstakes if it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices, or by abusing, threatening or harassing other entrants.

- Any use of robotic, macro, automatic, programmed or like entry methods will void all such entries and will subject such entrant to disqualification.
- Any attempt by a participant to deliberately damage any website or undermine the legitimate operation of the Sweepstakes is a violation of criminal and civil laws, and should such an attempt be made, Sponsor reserves the right to seek damages from any such participant to the fullest extent of the law.
